#### Decision: Major revisions required

The provided paper presents a study that aims to analyze the franchise agreement laws in Indonesia in relation to government regulations for technical assistance and the potential management of Indonesian franchise agreements. The study adopts a normative legal research design and examines franchise agreements and technology transfer within the intellectual property rights framework. Here are some suggestions for authors.

- The paper should provide a clear overview of the background and context of franchising in Indonesia, highlighting its growth and the regulations governing franchise activities.
- 2. The paper raises two main issues for investigation: the consideration of international provisions on technology transfer in Indonesian franchise agreement laws and the formal recognition of franchise agreements as legal instruments for technology transfer. However, it also must introduce the importance of technology transfer and intellectual property rights within franchise agreements.
- 3. While the paper covers a range of topics, some sentences could benefit from greater clarity and precision. For example, the sentence "Franchising is the sole possession of a corporate structure with particular features that have been demonstrated to be effective and can be utilized by other entities under the terms of a licensing agreement by an individual or an organization unit" is somewhat convoluted and could be rephrased for better comprehension.
- 4. The paper does not explicitly mention any existing research or literature on topic, leaving it unclear how this study contributes to the existing body of knowledge. Including a brief statement on the research gap or the novelty of the study would enhance the paper's impact.
- 5. The paper briefly mentions the findings of the study, stating that Indonesian

franchise agreements do not comply with the Transfer of Technology Code (TOT-Code) and establishedfranchise and agreement regulations. However, it does not provide further details or implications of these findings.

#### Decision: Major revisions required

By addressing the following points, the paper would provide a clearer and more comprehensive representation of the research, its findings, and its implications.

- The problem statement should be clear in highlighting the issue of Indonesia's need to enter into agreements with technology owners from other countries. The statement lacks specific details and context regarding the challenges faced by Indonesia in negotiating these agreements. It would be helpful to provide more background information and specific examples to enhance the clarity and depth of the problem statement.
- 2. The literature review section provide an overview of franchise registration laws and regulations in Indonesia and the concept of franchising and technology transfer. However, the review lacks critical analysis and synthesis of the existing literature. The references cited in the arguments and provide a comprehensive understanding of the topic.
- 3. The research methodology section describes the use of a normative legal research design. While this approach may be appropriate for studying laws and regulations, it would be valuable to explain why this research design was chosen and how it will effectively address the research objectives. Additionally, the section could benefit from further elaboration on data collection methods and analysis techniques to better understand the research process.
- 4. The result and analysis section lacks proper organization and clarity. The ideas are fragmented, making it difficult to follow the main arguments and their supporting evidence. It would benefit from better structuring and logical flow.
- 5. The paper includes citations, but it lacks a proper referencing style. It is important to provide accurate citations to allow readers to locate and verify the original sources. The citation format should follow a recognized referencing style (e.g., APA, MLA, etc.)
